Applicants desiring to become certified as structural pest control technicians must pass an examination. An application for the exam may be obtained from any one of the Regional Offices shown below or from the Department's Central Office at 525 West Jefferson Street, Springfield, Illinois 62761, telephone 217/782-5830.

In order to be eligible to write the examination at one of the scheduled examination sites, the application and fee must be submitted to the Department's Central Office no later than 15 days prior to the examination date. Confirmation letters will be issued to all qualifying applicants. **If you are unable to attend the scheduled examination, written notification must be submitted to, and received by, the Department at least two (2) business days prior to the examination date. If you fail to notify the Department as indicated or fail to show up for the scheduled examination, you will be required to file a new application and fee in order to be eligible to take the examination on another date. General Use Only Applicants - The Illinois Structural Pest Control Act requires that any individual using or overseeing the use of any general use pesticide while engaged in structural pest control for hire must be certified as a structural pest control technician (or work under the supervision of a certified structural pest control technician). Applicants must: 1) have a high school diploma or a GED certificate; 2) complete the "General Use" application and 3) submit the completed application and the fee as explained above.

Restricted Use Applicants - In order to qualify to write the sub-category examinations to use restricted pesticides in addition to the General Standards examination, an applicant must: 1) have a high school diploma or a GED certificate; 2) have at least six months experience in the categories to be taken (or provide evidence of meeting the educational requirements found in Section 5 of the Act); 3) complete the "Restricted Use" application and 4) submit the completed application and the fee as indicated above. The application must include verification of experience (such as the signature of a supervisor or employer).
